# **Domestic Homicide in New York State 2021**

This report presents a statistical account of domestic homicides reported by police departments and sheriffs' offices in 2021 to the New York State Division of Criminal Justice Services (DCJS).

**Definitions:** Domestic homicide is defined as a murder or non-negligent manslaughter in which the victim was known to have a domestic relationship with the offender, such as being an intimate partner or other family member.<sup>1</sup>

An "intimate partner" relationship includes spouse, ex-spouse, heterosexual or same-sex partner or ex-partner, whether or not the victim and offender lived together at the time of the incident or previously.<sup>2</sup> "Other family" member includes child under 18,<sup>3</sup> parent, sibling or other family relationship.

**Data:** The data analyzed for this report are taken from the Supplementary Homicide Report, submitted by police agencies to DCJS as of October 5, 2022.

Submitted as part of New York State's Uniform Crime Reporting program, the supplementary report includes caselevel information on all criminal homicides reported to police or sheriffs and includes the following information: victim-offender relationship; demographics of victims and offenders, such as sex, race/ ethnicity and age; and the type of weapons used.<sup>4</sup>

**Overview:** In this report, domestic homicides are compared to the total number of homicides statewide and in the state's two regions: the five counties (also known as boroughs) of New York City and Non-New York City, defined as the remaining 57 counties outside the five boroughs.

This report also details the demographic characteristics of all homicide and domestic homicide victims and the types of weapons used. Specific details also are included about:

- Intimate partner homicide, which is the most frequent type of domestic homicide;
- Homicides involving minor child victims; and
- Homicides with other family members as victims.

Statistics for the 10-year period from 2012 to 2021 and county-specific data also are included.

## **Major Findings**

- In 2021, domestic homicides accounted for 13.9 percent of all homicides reported in the state (123 of 882).
- Domestic homicides increased 6 percent compared to 2020, while non-domestic homicides increased by 5.1 percent.
- Statewide, there were 63 intimate partner homicides reported in 2021, a 3.3 percent increase compared to 61 in 2020.
- Intimate partners were responsible for 35.8 percent of homicides of female victims ages 16 and up, compared to 2.1 percent of male victims ages 16 and up.
- Knives, cutting instruments or blunt objects were most often used in intimate partner homicides (30 of 63 or 47.6 percent).
- A firearm was used in 38.5 percent of intimate partner homicides in New York City. Outside New York City, 27 percent of these homicides involved a firearm.

Murder and non-negligent manslaughter refer to crimes in New York State Penal Laws Section 125.15 through Section 125.27 and include: murder in the first and second degree, aggravated murder, aggravated manslaughter in the first and second degree, and manslaughter in the first and second degree.

Chart 1. 2021 Total Homicides by Victim to Offender Relationship in New York State

There were 882 homicides reported in 2021, and, of those, 123 (13.9 percent) involved a domestic relationship.

The victims and offenders were intimate partners in 63 of 123 domestic homicides. Intimate partner victims represented 51.2 percent of domestic homicide victims and 7.1 percent of all homicide victims.

The remaining 60 domestic homicide victims were killed by other family members. Those victims were most commonly the child, parent, or other family member of the offender.

Nine domestic homicide incidents reported in 2021 involved multiple victims.

Table 1 compares domestic and other homicides in New York City and Non-New York City in 2021. Of the 882 homicides reported statewide, 488 (55.3 percent) occurred in New York City and 394 (44.7 percent) occurred in the Non-New York City region. Appendix A details regional and county statistics.

## Table 1. Domestic Homicides and Other Homicides by Type of Relationship and Region<sup>5</sup>

- There were more homicide victims in New York City than in Non-New York City, but the percentage of homicides reported as domestic were more common outside of the five boroughs: 16.5 percent of all reported homicide victims were killed in domestic incidents outside New York City.
- New York City reported 58 domestic homicide victims, accounting for 11.9 percent of all homicide victims in the five boroughs.

Table 2 compares the sex of homicide victims who were 16 and older, statewide and by region. The vast majority, 95.2 percent, or 840 of 882 homicide victims, were 16 and older.

### Table 2. Victims of Homicide (Age 16 and Older) by Sex and Region

- Statewide, there were 134 female homicide victims who were age 16 or older, and, of those, 35.8 percent were killed by their intimate partner.
- In New York City, 36.1 percent of female victims were killed by an intimate partner, compared to 35.6 percent in Non-New York City.

<sup>5</sup> For this report, intimate partners include spouse, ex-spouse, heterosexual partner or ex-partner, and same-sex partner or ex-partner, whether or not the victim and offender were living together at the time of the homicide or had previously lived together. Domestic homicide statistics reported by NYPD include homicide victims who were killed in the incident, but were not intimate partners or members of the same family as the offender. These victims are excluded from domestic victim counts in this report.

# Domestic Homicides vs. all Homicides by Victim Sex

Charts 2 and 3 detail the number of female and male domestic homicide victims by type of relationship to the offender, compared to all homicide victims in the state.



Chart 2. 2021 Female Victim Homicides by Victim to Offender Relationship in New York State

- Statewide, 45.2 percent of the 146 female homicide victims were killed in a domestic homicide, either by an intimate partner or other family member.
- Among the 80 females killed in a non-domestic homicide, 18 were killed by a friend, acquaintance
  or someone otherwise known to the victim; 9 were killed by a stranger. The victim-offender relationship
  was listed as unknown or not reported for 53 female victims.

Chart 3. 2021 Male Victim Homicides by Victim to Offender Relationship in New York State



- The vast majority of males were killed in a non-domestic incident: 679 (92.3 percent) of 736.
- In stark contrast to female homicide victims, only 15 of the 736 (2 percent) male homicide victims were killed by an intimate partner and 42 (5.7 percent) by another family member.
- Among the 679 males killed in a non-domestic homicide, 106 were killed by a friend, acquaintance or someone otherwise known to the victim; and 64 were killed by a stranger. The victim to offender relationship was listed as unknown or not reported for 509 male victims.

# **Demographics of Homicide Victims**

Table 3 presents the sex and race/ethnicity of domestic and other homicide victims, by region. A synopsis of the statistics in this table follows on Page 6.

## <u>Sex</u>

- The victims of intimate partner homicides were most frequently female: 76.2 percent (48 of 63). Females were victims in 30 percent of domestic homicides by other family (18 of 60) and 10.5 percent (80 of 759) of all other homicides.
- Males were most often the victims in non-domestic homicides: 89.5 percent (679 of 759).

## Race and Ethnicity

#### **Non-Domestic Homicides**

• The majority (85.6 percent) of non-domestic homicide victims were either Black (67.1 percent) or Hispanic (18.6 percent).

#### All Domestic Homicides

- In domestic homicides, 41.5 percent (51) of victims were Black, 28.5 percent (35) were White and 22 percent (27) were Hispanic.
  - New York City reported more Black (29) and Hispanic victims (18) of domestic homicide than White victims (6).
  - In Non-New York City there were more White victims (29) of domestic homicide, than Black (22) or Hispanic (9).

#### **Intimate Partner Homicides**

- Among the 63 intimate partner homicide victims statewide, 33.3 percent (21) were White, 31.7 percent (20) were Black, and 27 percent (17) were Hispanic.
  - In New York City, there were 26 intimate partner homicides: 12 victims were Hispanic, eight were Black and three were White.
  - In Non-New York City, there were 37 intimate partner homicides: 18 victims were White, 12 were Black and five were Hispanic.

Table 4 presents domestic homicide victims by age group and type of relationship.

- Nine intimate partner victims were younger than age 30 in both Non-New York City and in New York City.
- Non-New York City had more intimate partner victims who were age 30 through 49, compared to New York City (18 versus 12).
- Non-New York City also had more intimate partner victims who were age 50 and older, compared to New York City (10 versus 5).

# **Child Victims of Domestic Homicide**

Table 5 presents demographics of child victims of domestic homicide. Child victims are those younger than 18 who were killed by a parent, a parent's intimate partner or another family member.

- Statewide, there were 24 child victims of domestic homicide: 13 in New York City and 11 outside New York City.
- Of those 24 child victims, 58.3 percent (14) were younger than five years old, and, of those, nine were infants.
- A parent was the perpetrator in 16 child victim homicides, an intimate partner of a parent was the perpetrator in two, a step-parent in one and a sibling in one. An "other family" member was the perpetrator in four.

# Adult Family Member Victims of Domestic Homicide

- For purposes of this report, an adult is defined as 18 years old or older.
- Statewide, there were 36 adult victims of domestic homicide: 12 parents; nine other family members, six siblings, four children, four in-laws, and one child of an intimate partner (*data not shown in table*).

## Weapons Used in Domestic Homicide

Table 6 details the type of weapon used in domestic homicides and the relationship of the victims to the offenders. Weapon types include firearms; knives, cutting instruments or blunt objects; personal weapons (hands, feet and teeth); and miscellaneous weapons (motor vehicle, fire and poison).

- A knife, cutting instrument or blunt object was the most common weapon used in all domestic homicides (53 of 123), followed by firearms (39 of 123), personal weapons (12 of 123) and miscellaneous weapons (12 of 123).
- Firearms were used in 38.5 percent of intimate partner homicides in New York City, compared to 27 percent of those that occurred outside New York City.
- In New York City, a knife, cutting instrument or blunt object was the weapon used against 42.3 percent of victims in intimate partner homicides.
- In Non-New York City, a knife, cutting instrument or blunt object was the weapon used against 51.4 percent of victims in intimate partner homicides.
- Among the 60 other family domestic homicides, 38.3 percent involved a knife, cutting instrument, or blunt object; 31.7 percent involved a firearm and 13.3 percent involved personal weapons (hands, feet, teeth).

## Trends in Domestic Homicide 2012 - 2021

The Division of Criminal Justice Services first published a Domestic Homicide Report in 2008, analyzing data from 2007. This section of the report compares domestic homicides annually for the 10-year period from 2012 through 2021. - Statewide, 2013 was the year with the most domestic homicides (145) and 2017 had the fewest (108).
- New York City had the fewest domestic homicides in 2015 (46), while Non-New York City reported the fewest in 2014 (57).



- The fewest number of intimate partner homicides during the 10-year period was 59 in 2017.
- There were 25 intimate partner homicides in New York City in 2019, the lowest reported since this report has been published. Those homicides outside New York City reached a low of 30 in 2018.

# Trends in Domestic Homicide 2012 - 2021

Figures 3 and 4 show child and other family homicides reported from 2012 through 2021.

• Statewide, child homicides increased by 41 percent from 2020 to 2021. The 13 child homicides reported by New York City in 2021 was up compared to last year but still below the 21 child victims reported in 2019. Non-New York City also reported an increase in child homicides this year (11) compared to last year (9).



• Other family homicides during 2021 were relatively consistent compared to last year. In 2021, New York City reported 19 and Non-New York City reported 17.
