Domestic Homicide in New York State 2020

This report presents a statistical account of domestic homicides reported by police departments and sheriffs' offices in 2020 to the New York State Division of Criminal Justice Services (DCJS).

Definitions: Domestic homicide is defined as a murder or non-negligent manslaughter in which the victim was known to have a domestic relationship with the offender, such as being an intimate partner or other family member.¹

An "intimate partner" relationship includes spouse, ex-spouse, heterosexual or same-sex partner or expartner, whether or not the victim and offender lived together at the time of the incident or previously.² "Other family" member includes child under 18,³ parent, sibling or other family relationship.

Data: The data analyzed for this report are taken from the Supplementary Homicide Report submitted by police agencies to DCJS as of July 12, 2021.

Submitted as part of New York State's Uniform Crime Reporting program, the supplementary report includes caselevel information on all criminal homicides reported to police or sheriffs and includes the following information: victim-offender relationship; demographics of victims and offenders, such as sex, race/ethnicity and age; and the type of weapons used.⁴

Overview: In this report, domestic homicides are compared to the total number of homicides statewide and in the state's two regions: the five counties (also known as boroughs) of New York City and Non-New York City, defined as the remaining 57 counties outside the five boroughs.

This report also details the demographic characteristics of all homicide and domestic homicide victims and the types of weapons used. Specific details also are included about:

- Intimate partner homicide, which is the most frequent type of domestic homicide;
- Homicides involving minor child victims; and
- Homicides with other family members as victims.

Statistics for the 10-year period from 2011 to 2020 and county-specific data also are included.

Major Findings

- In 2020, domestic homicides accounted for 14 percent of all homicides reported in the state (114 of 836).
- Domestic homicides decreased 17 percent compared to 2019, while non -domestic homicides increased by 66 percent.
- Statewide, there were 60 intimate partner homicides reported, a 9 percent decrease, compared to 66 in 2019. There were 29 in New York City, compared to 25 last year.
- Thirty-three percent of female homicide victims ages 16 and older were killed by their intimate partners, compared to 3 percent of their male counterparts.
- Knives, cutting instruments or blunt objects were most often used in intimate partner homicides (27 of 60 or 45%).
- A firearm was used in 45 percent of intimate partner homicides outside New York City. In New York City, 24 percent of these homicides involved a firearm.

¹ Homicide is defined as "the willful killing of one human being by another." *Uniform Crime Reporting Handbook*. Murder and non-negligent manslaughter refer to crimes in New York State Penal Laws Section 125.15 through Section 125.27 and include: murder in the first and second degree, aggravated murder, aggravated manslaughter in the first and second degree, and manslaughter in the first and second degree.

³ "Child" is defined as an individual who is under 18 years old and is a biological or adopted child.

⁴ New York City homicide data are extracted from the New York City Police Department Shootings and Homicides database, which differs from the Supplementary Homicide Report but not in ways that substantially affect this analysis.



Chart 1. 2020 Total Homicides by Victim to Offender Relationship in New York State

There were 836 homicides reported in 2020, and, of those, 114 (13.6 percent) involved a domestic relationship.

The victims and offenders were intimate partners in 60 of 114 domestic homicides. Intimate partner victims represented 52.6 percent of domestic homicide victims and 7.2 percent of all homicide victims.

The remaining 54 domestic homicide victims were killed by other family members. Those victims were most commonly the child, parent, or other family member of the offender.

Five domestic homicide incidents reported in 2020 involved multiple victims. In one of those incidents, the perpetrator also committed suicide. The perpetrator was an adult male in four of the five incidents, including three murder-suicides:

- A male offender killed his girlfriend and the girlfriend's father.
- A male offender killed his wife and their 12-year-old daughter, then committed suicide.
- A male offender killed his former partner and her mother.
- A female offender killed her two sons, then committed suicide.
- A male offender killed his father and sister, then committed suicide.

Table 1 compares domestic and other homicides in New York City and Non-New York City in 2020. Of the 836 homicides reported statewide, 468 (56 percent) occurred in New York City and 368 (44 percent) occurred in the Non-New York City region. Appendix A details regional and county statistics.

- There were more homicide victims in New York City than in Non-New York City, but homicides reported as domestic were more common outside of the five boroughs: 15.8 percent of all reported homicide victims were killed in domestic incidents outside New York City, compared to 12 percent in New York City.
- New York City reported 56 domestic homicide victims, accounting for 12 percent of all homicide victims in the five boroughs.

Table 2 compares the sex of homicide victims who were 16 and older, statewide and by region. The vast majority, 96.4 percent, or 806 of 836 homicide victims, were in that age group.

- Statewide, there were 120 female homicide victims who were 16 or older, and, of those, 32.5 percent were killed by their intimate partner.
- In New York City, 33.3 percent of female victims were killed by an intimate partner, compared to 31.8 percent in Non-New York City.

⁵ For this report, intimate partners include spouse, ex-spouse, heterosexual partner or ex-partner, and same-sex partner or ex-partner, whether or not the victim and offender were living together at the time of the homicide or had previously lived together. Domestic homicide statistics reported by NYPD include homicide victims who were killed in the incident, but were not intimate partners or members of the same family as the offender. These victims are excluded from domestic victim counts in this report.

Domestic Homicides vs. all Homicides by Victim Sex

Charts 2 and 3 detail the number of female and male domestic homicide victims by type of relationship to the offender, compared to all homicide victims in the state.



Chart 2. 2020 Female Victim Homicides by Victim to Offender Relationship in New York State

- Statewide, 48 percent of the 127 female homicide victims were killed in a domestic homicide, either by an intimate partner or other family member.
- Among the 66 females killed in a non-domestic homicide, 15 were killed by a friend, acquaintance
 or someone otherwise known to the victim; 11 were killed by a stranger. The victim-offender relationship
 was listed as unknown or not reported for 40 female victims.

Chart 3. 2020 Male Victim Homicides by Victim to Offender Relationship in New York State



- The vast majority of males were killed in a non-domestic incident: 656 (92.7 percent) of 708.
- In stark contrast to female homicide victims, only 20 of the 708 (2.8 percent) male homicide victims were killed by an intimate partner and 32 (4.5 percent) by another family member.
- Among the 656 males killed in a non-domestic homicide, 117 were killed by a friend, acquaintance or someone otherwise known to the victim; and 31 were killed by a stranger. The victim to offender relationship was listed as unknown or not reported for 508 male victims.

Demographics of Homicide Victims

Table 3 presents the sex and race/ethnicity of domestic and other homicide victims, by region. A synopsis of the statistics in this table follows on Page 6.

<u>Sex</u>

- The victims of intimate partner homicides were most frequently female: 65 percent (39 of 60). Females were victims in 40.7 percent of domestic homicides by other family (22 of 54) and 9.1 percent (66 of 722) of all other homicides.
- Males were most often the victims in non-domestic homicides: 90.9 percent (656 of 722).

Race and Ethnicity

Non-Domestic Homicides

• The majority (87.5 percent) of non-domestic homicide victims were either Black (65.5 percent) or Hispanic (22 percent).

All Domestic Homicides

- In domestic homicides, 40.4 percent (46) of victims were Black, 35.1 percent (40) were White and 21.1 percent (24) were Hispanic.
 - New York City reported more Black (25) and Hispanic victims (21) of domestic homicide than White victims (8).
 - In Non-New York City there were more White victims (32) of domestic homicide, than Black (21) or Hispanic (3).

Intimate Partner Homicides

- Among the 60 intimate partner homicide victims statewide, 35 percent (21) were White, 35 percent (21) were Black, and 25 percent (15) were Hispanic.
 - In New York City, there were 29 intimate partner homicides: 12 victims were Hispanic, 11 were Black and five were White.
 - In Non-New York City, there were 31 intimate partner homicides: 16 victims were White, 10 were Black and three were Hispanic.

Table 4 presents domestic homicide victims by age group and type of relationship.

- There were same number of intimate partner victims younger than 30 in Non-New York City and in New York City (7).
- New York City had more intimate partner victims (58.6 percent) who were 30 through 49, compared to Non-New York City (38.7 percent).
- Non-New York City had more intimate partner victims (38.7 percent) who were age 50 and older, compared to Non-New York City (17.2 percent).

Child Victims of Domestic Homicide

Table 5 presents demographics of child victims of domestic homicide. Child victims are those younger than 18 who were killed by a parent, a parent's intimate partner or another family member.

- Statewide, there were 17 child victims of domestic homicide: eight in New York City and nine outside New York City.
- Of those 17 child victims, 76.5 percent (13) were younger than five years old, and, of those, five were infants.

• A parent was the perpetrator in 12 child victim homicides, a step-parent in one, and an intimate partner of a parent in one. An "other family" member was the perpetrator in three.

Adult Family Member Victims of Domestic Homicide

- For purposes of this report, an adult is defined as 18 years old or older.
- Statewide, there were 37 adult victims of domestic homicide: 10 parents; five other family members; two in-laws; one sibling; and one child (*data not shown in table*).

Weapons Used in Domestic Homicide

Table 6 details the type of weapon used in domestic homicides and the relationship of the victims to the offenders. Weapon types include firearms; knives, cutting instruments or blunt objects; personal weapons (hands, feet and teeth); and miscellaneous weapons (motor vehicle, fire and poison).

• A knife/cutting instrument or blunt object was the most common weapon used in all domestic homicides (44 of 114), followed by firearms (37 of 114) and miscellaneous weapons (18 of 114).

- Firearms were used in 37.9 percent of domestic homicides outside New York City, compared to 26.8 percent of those that occurred in New York City.
- In New York City, a knife, cutting instrument or blunt object was the weapon used against 55.2 percent of victims in intimate partner homicides.
- In Non-New York City a firearm was used in 45.2 percent of intimate partner homicides, and knife, cutting instrument or blunt object was used in 35.5 percent of intimate partner homicides.
- Among the 54 other family domestic homicides, 31.5 percent involved a knife, cutting instrument, or blunt object; 29.6 percent involved a firearm and 22.2 percent involved miscellaneous weapons.

Trends in Domestic Homicide 2011 - 2020

The Division of Criminal Justice Services first published a Domestic Homicide Report in 2008, analyzing data from 2007. This section of the report compares domestic homicides annually for the 10-year period from 2011 through 2020. - Statewide, 2011 was the year with the most domestic homicides (171) and 2017, was the lowest (107).
- New York City had the fewest domestic homicides in 2015, while Non-New York City reported the fewest in 2014.

- The fewest number of intimate partner homicides during the 10-year period was 58 in 2017.
- There were 25 intimate partner homicides in New York City in 2019, the lowest reported since this report has been published. Those homicides outside New York City reached a low of 29 in 2018.

Trends in Domestic Homicide 2011 - 2020

Figures 3 and 4 show child and other family homicides reported from 2011 through 2020.

• Statewide, child homicides decreased by 55.3 percent from 2019 to 2020. The eight child homicides reported by New York City in 2020 was the lowest in the last 10 years. There were nine child homicides reported outside New York City during the same period, almost half the number reported in 2019.
